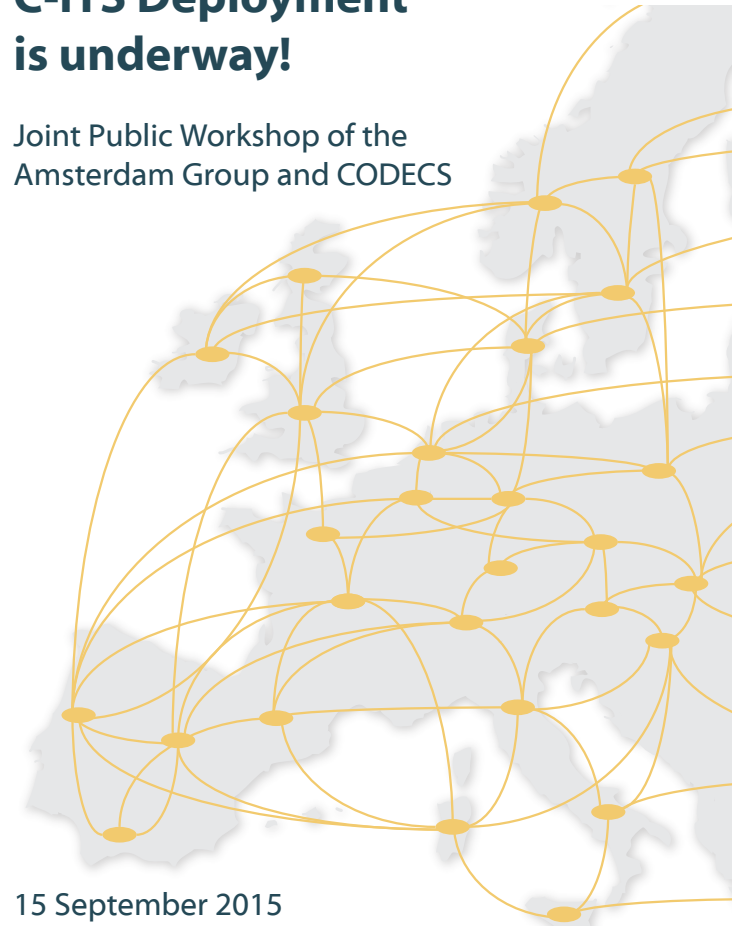
CODECS

CODECS (**CO**operative ITS **DE**ployment **CO**ordination **S**upport) acts as nodal point pooling the interests of stakeholders involved in the consecutive C-ITS implementation phases. It builds up a stakeholder network and, through interactive discussion in workshops, webinars and personal interviews, CODECS-partners identify functional approaches, roles & responsibilities, preferred use cases and requirements for strategic decision making. Out of the consolidated stakeholder needs and priorities, it develops guidelines for initial deployment as well as testing, specification and standardisation in later innovation phases.
